1. Applicant must be at least 13 by August 14th, 2015 and not have reached her 20th birthday as of August 14th, 2015.
2. Applicant must be born female, single, never married, never pregnant, never a parent, and never had a marriage annulled.
3. Applicant must be a resident of California for at least six months, and be a U.S citizen.
4. Applicant must be of good moral character and never convicted of a crime.
5. Applicant agrees that all fees paid to Crown U Productions are non-refundable.
6. Applicant understands and agrees that she must adhere to all imposed deadlines.
7. Applicant understands that failure to comply with any of terms, shall at the option of the pageant, result in her being disqualified from competition.
8. Applicant agrees that all photos and paperwork are not returned.
9. Applicant agrees to be judged in the areas of Personal Interview, Activities & Achievement, Personality, Poise & Appearance. There is no swimsuit or talent competition.
10. Applicant agrees to exhibit good sportsmanship throughout the competition.
11. Applicant agrees to abide by all the Rules & Regulations now in effect, or any new rules & regulations mandated in the future.
12. Applicant agrees that she shall forfeit the local title awarded to her by the State Selection Committee, if she is accepted but does not participate in the pageant

Achievements & Activities 1/3

Delegates will have their application materials reviewed by the Activities & Achievement Committee, who will review achievements, school activities and life goals. (If accepted to participate, you may submit additional materials prior to the pageant.)

Interview & Personality 1/3

Delegates will be judged on their abilities of self-expression, poise both onstage and in a two-minute personal interview with the judges.

Poise & Appearance 1/3

Delegates will be evaluated in an evening gown of their choice. The gown should reflect the girl's age and personality. Good grooming, posture, poise and overall appearance will be evaluated.
